Project Description: The Ojai fuel bed, fire roads and fuel breaks provide a fire access and defensible space for the communities contained within the project location. The following are fire roads and fuel breaks within the fuel bed: Ferndale Fire Road approx 3 miles with access from Hwy 150 east on Koenigstein Road. Cozy Dell Fire Road approx.7 miles with access from Maricopa Hwy. Gridley Fire Road approx 3.2 mile swith access from Gridley Canyon Road. Shelf Road/Valley View Fire Road approx 1.725 miles with access from Signal Street from the west and Gridley Road from the east. The existing fire road systems are not all weather roads and require annual maintenance. Existing fire road systems will be maintained by the use of heavy equipment which could include dozer, road grader and back hoe.
